1. Biography

Hearn was born in San Francisco, California, on April 25, 1949. He was raised in Lafayette, California, a suburb in the San Francisco East Bay, and attended public schools. His father was a corporate executive in a clothing company in San Francisco and his mother was a housewife. He was raised in traditional Irish Catholic fashion and, entered a seminary as a young man, and briefly considered the priesthood. Hearn enrolled in California State University at Chico in 1967, majoring in psychology and sociology. He graduated with a two Bachelor's degree. Hearn moved to Spokane, Washington, following graduation and worked for two years at a residential treatment center for delinquent youth. Hearn moved to Sandpoint, Idaho, in early 1976, and has remained an Idaho resident since then. Hearn was hired by the Idaho Department of Health and Welfare in January 1977 as a Child Protective Services social worker in Sandpoint and assigned to investigate allegation of child abuse, neglect and abandonment in Bonner County, Idaho. He has been married to Kathy (Johnson) Hearn since 1980. The Hearns temporarily moved to Seattle, to allow Hearn to attend the University of Washington. Hearn returned to the Idaho Department of Health and Welfare Coeur d'Alene office in 1981, completed his academic work and was awarded a Masters Degree in Clinical Social Work.

The Hearns have two children, Molly and Patrick, who were born and raised in Coeur d'Alene. Kathy is now a retired teacher, having spent most of her career in the Post Falls School District working in special education with severely disabled children. Hearn began a part-time private practice in 1983 and, in 1986, resigned from governmental service to pursue a private practice full-time. Initially a part owner of Interfaith Family Counseling Services, Hearn became the sole owner of North Idaho Treatment Associates in 1995 until his retirement in September 2013. Hearn's mental health clinic specialized in the assessment and treatment of physical and sexual abuse victims and perpetrators. The Hearns have four young grandchildren. Three reside with their parents, Molly and Trevor Smith, and attend Coeur d'Alene public schools. The fourth

resides with her parents and attends school in Pahoa, Hawaii.

Tom Hearn was elected to the Coeur d'Alene School Board in May 2013. He was elected in Zone 5, encompassing the central area of Coeur d'Alene, by nearly 70% of the vote. This was Hearn's first venture into holding elected public office. Hearn has written many issue-oriented letters that have been printed in the Coeur d'Alene Press over the years, and has openly supported numerous Democratic candidates in local, state, and national campaigns. Based on his established knowledge, integrity and good standing within his profession, Hearn was appointed by three governors--Cecil Andrus, Dirk Kempthorne and Butch Otter--to state boards as well as by two Attorneys General--Jim Jones and Alan Lance--to state task forces. He has testified before the legislature a number of times as a member of these state boards and task forces.

Supplemental levies are now nearly 1/4 of the Coeur d'Alene School district's budget. Supporting great public schools, adequate public services, infrastructure improvement for our highways and broadband infrastructure is investing in our communities. Half of our Idaho college graduates move away from Idaho within 4 years. We need to make Idaho, and Coeur d'Alene, a place where young parents can get a job that pays enough to support their families.
