NOTICE OF FILING REQUIREMENTS

Dear Political Treasurer:

Pursuant to the provisions of Sections 67-6615 and 67-6625A, Idaho Code, you are hereby notified that the Secretary of State has not received a Pre-Primary Campaign Financial Report required by Sections 67-6607 and 67-6608, Idaho Code, which was **due May 16, 2006 by 5 pm**. This report covers the period from January 1, 2006 through May 7, 2006. Pursuant to Section 67-6609, Idaho Code, a report shall be filed although there may have been no financial activity.

Section 67-6625A, Idaho Code, states that any person who fails to file a report on or before a specified date shall be liable for a penalty of fifty dollars (\$50.00) for each day the report is late. If the report is not filed within five (5) days after receiving notice of the filing requirements said person may be subject to the additional penalties prescribed in Section 67-6625, Idaho Code.
