<b>H 41 Relating to Property Tax Petitions (by Moyle):</b> Would allow residents of a local taxing district to collect signatures for a ballot question to reduce the property tax portion of the taxing districts budget. Schools would be exempt.	OPPOSE	House Rev and Tax
<b>H 45 Relating to Bonds for Contractors (by Black and Andreason):</b> This legislation would add a \$10,000 bonding requirement to contractor registration - as well as other professions.	OPPOSE	House Business
